Meeting Between Federal Reserve Staff and a Representative of World Council of Credit Unions (WOCCU) and a Representative of Credit Union National Association (CUNA) October 15, 2010

Participants: David Grace (WOCCU) and Michael Edwards (CUNA)

Dana Miller, Samantha Pelosi, Mandie Aubrey (via phone), David Stein, Ky Tran-Trong, and Vivian Wong (Federal Reserve Board)

Summary: Staff from the Federal Reserve Board met with a representative of WOCCU and a representative of CUNA to discuss the remittance transfer provisions of the Dodd-Frank Wall Street Reform and Consumer Protection Act. The WOCCU and CUNA representatives explained the various methods that credit unions use to transfer money abroad. The WOCCU representative provided an overview of its international remittance network, IRnet. The WOCCU and CUNA representatives raised concerns about certain aspects of the remittance transfer provisions of the Dodd-Frank Act, including the posting of storefront and internet disclosures containing information about model transfers, promised date of delivery appearing in the receipt, foreign language disclosures, error resolution, cancellation policies, and liability for agent actions. The participants also discussed the exceptions that permit the use of estimates in disclosing the amount of foreign currency to be paid to the recipient.

Subsequent to the meeting, WOCCU provided copies of the receipts issued and electronic records produced for sample transactions processed through Vigo, a participant in the IRnet system. Copies of these materials are attached.
