Value added and Gross value: These weights were estimated from information contained in the Annual Survey of Manufactures, Census of Manufactures and the Census of Mineral Industries, and reports from the Department of Energy, the Edison Electric Institute, and the American Gas Association. The figures may not add to totals because of rounding.

2. Individual and aggregate series have been compiled on a consistent NAICS basis back to 1972. Major aggregates and groupings were linked to their corresponding pre-1972 SIC-based counterparts. Many industries are apportioned among several market groups. The value added and gross value figures for these series (marked with footnote 2) are apportioned accordingly. For the total value added and gross value for a given industry, see *Table 1, Industry Structure of Industrial Production* (www.federalreserve.gov/releases/G17/SandDesc/sdtab1.pdf).

3. The individual series that comprise the total index include those industries in mining, utilities, and manufacturing. Manufacturing comprises those industries in the North American Industrial Classification System, or NAICS, definition of manufacturing plus the logging and newspaper, periodical, book, and directory publishing (except exclusive Internet publishing) industries that have traditionally been considered manufacturing.
