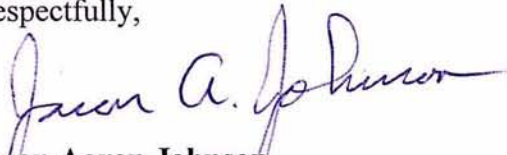
**SUBJECT: Customary & Reasonable Fees for Appraisers
