Nonmember banks who become members should report base data to the Reserve Bank for the period Sept. 13-26, 1979.FR 2414y:All member banks and all domestic and foreign Edge Act and Agreement Corporations. Only member banks with total deposits greater than \$75 million and additional smaller member banks that the Reserve Bank has determined to have significant total managed liabilities.

FR 2414z:

Member banks, Edge Act or Agreement Corporations engaged in the banking business, and families of U.S. branches and agencies of a bank organized under foreign law that have consolidated worldwide banking assets of more than \$1 billion whose managed liabilities base for calculation of marginal reserve requirements is greater than \$100 million.

Banks that are members of the Federal Reserve System and Edge Act and Agreement Corporation engaged in the banking business.

FR 2414d:

Member banks, Edge Act or Agreement Corporations engaged in the banking business, and families of U.S. branches and agencies of a bank organized under foreign law that have consolidated worldwide banking assets of more than \$1 billion whose managed liabilities base for the calculation of marginal reserve requirements is greater than \$100 million.

FR 2412c:

Commercial banks that are not members of the Federal Reserve System whose total liabilities on December 31, 1979, were \$150 million or more.
