Dear Mr. Christiansen:

This is in response to your letter dated February 18, 2014, on behalf of BankUnited, Inc. ("BankUnited") and BankUnited, National Association ("Bank"), both of Miami Lakes, Florida, requesting relief from passivity commitments ("Commitments") made by The Blackstone Group, WL Ross & Co. LLC and Invesco Ltd., and Centerbridge Partners, L.P., each of New York, New York, and The Carlyle Group, Washington, D.C. (together with their affiliates, the "Covered Shareholders"), to the Board in connection with the Covered Shareholders' investment in BankUnited. BankUnited seeks relief from the Commitments on behalf of the Covered Shareholders, asserting that the Commitments are no longer necessary to prevent the Covered Shareholders from exercising a controlling influence over BankUnited.

Each Covered Shareholder made the Commitments in connection with its ownership of between 9 percent and 14.87 percent of BankUnited's voting common stock and a contractual right to a director representative on the boards of BankUnited and Bank. The Commitments were consistent with commitments that the Board previously has accepted in determining that a company did not control another company for the purposes of the Bank Holding Company Act and the Board's Regulation Y.

Specifically, each Covered Shareholder provided the Commitments to ensure that it would not exercise or attempt to exercise a controlling influence over BankUnited. Circumstances have since changed. The Covered Shareholders have completely divested their ownership interests in BankUnited and, thus, are presumed not to control BankUnited.² In addition, the Covered Shareholders no

longer have any contractual right to a director representative on the boards of BankUnited or Bank, and their current director representatives will leave the BankUnited and Bank boards when their terms expire at the next shareholders' meeting to be held in May 2014. The parties have represented that there are no existing or anticipated business relationships between the Covered Shareholders and their affiliates, on the one hand, and BankUnited and its affiliates, on the other hand. Each Covered Shareholder also has represented that neither it nor its affiliates would exercise or attempt to exercise a controlling influence over BankUnited or any of its affiliates in the event that complete relief from the Commitments is granted.

Based on all the facts of record, the Director of the Division of Banking Supervision and Regulation, acting pursuant to authority delegated by the Board under section 265.7(a)(2) of the Board's Rules Regarding Delegation of Authority,⁴ and after consulting with the General Counsel, has approved BankUnited's request for relief from the Covered Shareholders' Commitments related to BankUnited. This action is based on the representations and commitments set forth in your submission of February 18 and in all subsequent correspondence related to this request. Any change in the facts presented could result in a different conclusion and should be reported to Board staff immediately.
