Reporting Panel

FR 2071a/a-n:

Beginning November 1983, consists of a sample of approximately 425 insured banks, including all banks with total deposits of more than \$1 billion as of December 31, 1977 that offer ATS, NOW Accounts, (?Super NOW@Accounts were no longer collected separately as of February 28, 1986) or MMDA's as well as other insured commercial banks that offer these accounts, chosen on a stratified random basis. The majority of respondents file the FR 2071a report form; however, respondents located in Districts 1, 2, and certain respondents in District 3 file the FR 2071a-n form, which excludes the NOW/ATS item.

Major Changes to Reporting Panel

Prior to November 1983, consisted of a sample of approximately 400 insured banks and did not include banks in New England or New York, where NOW accounts has been available for several years. Until February 1983, included banks in New Jersey, where NOW accounts had been available since 1979, but 10 banks located in New Jersey were eliminated from the sample.

Quarterly figures. (For the FR 2071b to the nearest percentage point.)

Major Series Changes

Beginning February 28, 1986, ?Super NOW@accounts were blocked out on the report form with the reduction of the minimum balance requirement for ?Super NOW@accounts from \$1,000 to zero. There is no longer a regulatory distinction between ?NOW@accounts and ?Super NOW@accounts; therefore, separate collection of data on ?Super NOW@accounts is no longer necessary.

Beginning February 28, 1985, the minimum balance requirement for MMDA's and ?Super NOW@accounts was reduced from \$2500 to \$1000.

Beginning November 1983, the number of accounts data previously provided in the monthly FR 2071c and FR 2071d were incorporated in the quarterly FR 2071a to include MMDA's and ?Super NOW's.@ A breakdown of MMDA's into personal and nonpersonal categories also was included.

Beginning February 1983, one item, ?Number of Telephone or Preauthorized Transfer Accounts@ was eliminated from the FR 2071a report form.
