## Notes on the Data (billions of dollars)

Due to the conversion of a thrift to a commercial bank during the week ending March 2, 2016, the assets and liabilities of domestically chartered commercial banks increased \$4.9 billion. The major asset items affected were: real estate loans, closed-end real estate loans, \$1.8; real estate loans, commercial real estate loans, construction and land development loans, \$0.6; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$0.6; and other asset items, \$1.9. The major liability items affected were: deposits, other deposits, \$2.9; borrowings, borrowings from others, \$1.0; and other liability items, \$0.5. The residual (assets less liabilities) increased \$0.5.
