VA APPRAISAL FEES

- ⊙ **Study Population:**
 - ⊙ 11,466 randomly-selected real estate appraisers including:
 - ⊙ 2,057 SRA members
 - ⊙ 2,409 Residential Associate members
 - ⊙ 7,000 nonmember appraisers.
- ⊙ **Survey Instrument:**
 - ⊙ Online, self-administered questionnaire with security features.
- ⊙ **Communication method:**
 - ⊙ Survey invitation was sent via email on September 28, 2010.
- ⊙ **Respondent Cooperation Rate (response rate):**
 - ⊙ 5.6 percent.
- ⊙ **Survey Sample Size:**
 - ⊙ 614 (416 AI members and 198 nonmember appraisers).
 - ⊙ Responses are broadly distributed geographically.
- ⊙ **Margin of Error (at the 95 percent Confidence Level):**
 - ⊙ +/- 3.9 percentage points (based on a U.S. appraiser population of 93,750).

- ⦿ Research Objective
 - ⦿ Determine whether Department of Veterans Affairs appraisal and inspection fees are comparable to customary and reasonable appraisal fees for similar non-VA appraisals and inspections.

Very reasonable	23.9%	25.7%	20.2%
Reasonable	47.2%	53.9%	32.6%
Somewhat unreasonable	12.5%	15.7%	5.7%
Not reasonable at all	3.9%	4.0%	3.6%
Not sure	12.4%	0.7%	37.8%

Slight to strong majorities of respondents said VA appraisal and inspection fees are “Reasonable” or “Very reasonable.”

“Do Not Do VA Appraisals” is the proportion of the total survey sample that does not do VA appraisals.

VA APPRAISAL FEES

Do the VA appraisal fee levels for your area encourage you to do, or discourage you from doing, VA appraisals or inspections?

Encourages	38.9%	44.2%	27.5%
Neither encourages nor discourages	41.7%	46.8%	30.6%
Discourages	7.5%	7.6%	7.3%
Not sure	11.9%	1.4%	34.7%

Though a plurality of respondents selected “Neither encourages nor discourages,” nearly comparable proportions of respondents selected “Encourages.” This affirms the overall opinion of respondents that VA appraisal fees are on par with fees for similar non-VA appraisal and inspection assignments.

Significant majorities or pluralities of respondents rated VA appraisal fees “On Par” with comparable non-VA appraisal fees. However, for all categories of VA appraisal fees the pluralities of responses for “Below Par” were equal to or greater than the pluralities of responses for “Above Par.” This suggests that when VA appraisal fees are not on par, the fees apparently tend to be below par more often than above par.
