

Dear Comptroller Curry, Chairman Bernanke, and Acting Chairman Gruenberg:

We here at Kress National see the horrible harm that is about to be handed our community banks and customers regarding the Basel III Notice of Proposed Regulations. We would like to see Kress National Bank around for another 50+ years.

Even though there are a few good intentions behind these regulations, such as strong capital requirements, continued strengthening of mortgage lending, etc. the regulatory burden has been and will continue to be tremendous.
