Your comment:Thank you for the opportunity to comment on the Advance Notice of Proposed Rulemaking (ANPR) entitled "Community Reinvestment Act," which was published in the Federal Register on October 19, 2020 by the Board of Governors of the Federal Reserve System ("the Board"). This is a critically important rulemaking, and NeighborWorks applauds the Board's efforts to develop a regulatory framework for the Community Reinvestment Act (CRA) that appropriately balances the desire to provide certainty and clarity to regulated institutions with the fundamental purposes of the CRA statute to effectively meet the needs of low- and moderate-income communities and address inequities in access to credit. NeighborWorks is deeply appreciative of the Board's ongoing commitment to providing community stakeholders with meaningful opportunities to engage and shape these regulations.
