#### Comment on a Proposed Rule

Unfortunately, this Proposed Rule came to our attention after the end of the comment period. Nonetheless, the PDF Association wishes to register a technical comment regarding manifest errors in references to "PDF/A" in the Proposed Rule for the US Financial Data Transparency Act, specifically in this paragraph:

## Background for this comment

The paragraph above references "PDF/A." This appears to refer to the ISO-standardized subset of the PDF file format addressing long-term preservation, defined by the ISO 19005 family of standards. However, this paragraph makes materially incorrect assertions about PDF/A and fails to specify which part(s) and conformance level(s) of PDF/A are necessary to meet the Rule's requirements. This lack of specificity inhibits a common understanding of the requirements and, thus, any industry response.

We write in the hope that these facts may be corrected and that the Rule be enhanced to include accurate, salient requirements regarding the use of PDF and its associated international standards to advance the purpose of the Rule.

### Specific concerns

Hereunder we quote the text of the rule and provide comments.

In the above-referenced paragraph, the text of the rule asserts:

...PDF may satisfy the standard if the data within the PDF conforms to specification "A" (PDF/A) that uses advanced features for tagging fields with a reference schema and taxonomy...

**The facts:** While <u>permitting</u> the use of the described features, <u>PDF/A does not include any substantive provisions regarding these features</u> in terms of tagging fields or for use with reference schemas and taxonomies. The features referenced in the Rule's paragraph are native to PDF itself (as defined by ISO 32000), <u>not PDF/A</u>, which deals primarily with the long-term preservation of documents.

The PDF Association recommends the rule be corrected to explicitly state compliance to PDF/A-3 (ISO 19005-3) for PDF version 1.x, or PDF/A-4 (ISO 19005-4) for PDF 2.0, to ensure that the recordkeeping requirements of 44 U.S.C. 3502(13) are achieved. Furthermore, both these standards support conformance levels that permit the use of "tagged fields" (technically, "Tagged PDF") as well as the embedding of "schema and taxonomy data" to "provide necessary metadata that allows for automated data extraction".

Additionally, conformance to the appropriate parts of PDF/UA (ISO 14289) ensures that the same PDF documents will meet accessibility requirements for, e.g., the Americans with Disabilities Act (ADA), Section 508 of the US Rehabilitation Act of 1973, or other as applicable.

### Proposed replacement text (bold face indicates proposed replacement)

PDF will satisfy the standard if the PDF files conform to PDF/A-3 (ISO 19005-3) for PDF version 1.x, or PDF/A-4 (ISO 19005-4) for PDF 2.0, to comply with the recordkeeping requirements of 44 U.S.C. 3502(13). PDF files conforming to these ISO standards support the use of "Tagged PDF" and the embedding of schema and taxonomy data allowing automated data extraction. Additionally, the same PDF files may conform to PDF/UA-1 (ISO 14289-1) for PDF version 1.x or PDF/UA-2 (ISO 14289-2) for PDF 2.0 if support for accessibility features is required. HTML and PDF documents whose data does not conform to any such schema and taxonomy would not be considered machine-readable as that term is defined in the FDTA because the data contained in such HTML and PDF documents cannot be easily processed by a computer without human intervention while ensuring no semantic meaning is lost.
