

Mr. Hurwitz,

The Connecticut Fair Housing Center is the only nonprofit in Connecticut that represents and advocates for homeowners facing foreclosure statewide. On behalf of the thousands of homeowners with whom we speak each year, I write to (1) oppose the proposed merger between CIT Group and OneWest Bank and (2) ask that public hearings be held regarding the merger.

We are particularly concerned about CIT Group's apparent willingness to keep OneWest's servicing practices in place without any plans for improvement. OneWest is disproportionately responsible for the servicing complaints we receive -- in particular, its underresourced loss mitigation department often engages in a "document dance" few servicers can match -- and its affiliate Financial Freedom is disproportionately responsible for the reverse mortgage foreclosures we see. The latter issue is particularly troubling, as seniors who should have never received Financial Freedom's products face loss of their longtime homes because of poor underwriting and nonexistent loss mitigation practices.

Without a real plan and resources devoted to improving OneWest's shameful servicing practices, we cannot support an acquisition that would only enrich the executive team and shareholders without any benefit to the customers and the public. We strongly oppose approval of the merger and ask, at a minimum, that you hold public hearings regarding the proposed deal.

The Connecticut Fair Housing Center is the only nonprofit in Connecticut that represents and advocates for homeowners facing foreclosure statewide. On behalf of the thousands of homeowners with whom we speak each year, I write to (1) oppose the proposed merger between CIT Group and OneWest Bank and (2) ask that public hearings be held regarding the merger.

We are particularly concerned about CIT Group's apparent willingness to keep OneWest's servicing practices in place without any plans for improvement. OneWest is disproportionately responsible for the servicing complaints we receive -- in particular, its underresourced loss mitigation department often engages in a "document dance" few servicers can match -- and its affiliate Financial Freedom is disproportionately responsible for the reverse mortgage foreclosures we see. The latter issue is particularly troubling, as seniors who should have never received Financial Freedom's products face loss of their longtime homes because of poor underwriting and nonexistent loss mitigation practices.

Without a real plan and resources devoted to improving OneWest's shameful servicing practices, we cannot support an acquisition that would only enrich the executive team and shareholders without any benefit to the customers and the public. We strongly oppose approval of the merger and ask, at a minimum, that you hold public hearings regarding the proposed deal.
