Subject: Meetings with State bankers

From Office of the Secretary

and related groups in 1970.

The Washington Office of the American Bankers Association has been in touch with us about arrangements for the annual visits to the Board by the various State banker groups during the winter and spring months of 1970. Attached is a list of proposed dates on which such groups wish to visit the Board. (As you will note, the list also gives the dates on which the various groups are planning to host receptions and dinners to which the members of the Board would be invited.)

We have also been contacted in a similar connection by the Consumer Bankers Association and the National Association of Mutual Savings Bankers; presumably, we will also hear from the National Association of Supervisors of State Banks and the Bank Administration Institute (formerly National Association of Bank Auditors and Controllers).

According to the pattern that has been established during recent years, a member of the Board and two staff members, including one from the Division of Supervision and Regulation, would attend--on a rotating basis--the receptions and dinners given by the respective groups. Following the practice of past years, each group would be invited to the Board's offices for luncheon at which attendance would include a member of the Board and an appropriate number of staff. Following the luncheon, the Board member hosting the luncheon would confer with the visitors in the Board Room (in several instances the conference has taken place in the dining room).

Assuming the Board wishes to continue the practice that it has followed over the years, the Secretary's Office will proceed promptly with the necessary arrangements for hosting the luncheons/conferences and providing representation at the receptions/dinners.
