RE: OUTRIGHT PURCHASE OF YEN BY ESF AND FEDERAL RESERVE SYSTEM

AS REFERRED TO DURING THE TELEPHONE MEETING ON JULY 20, THE TREASURY HAS NOW COMPLETED ARRANGEMENTS WITH THE JAPANESE MINISTRY OF FINANCE (MOF) TO PURCHASE DIRECTLY FROM THE MUF YEN IN AN AMOUNT OF \$2 BILLION EQUIVALENT, WITH A POSSIBLE ADDITIONAL \$1 BILLION EQUIVALENT TO BE DECIDED LATER. THE YEN WILL BE PURCHASED ON AN OUTRIGHT BASIS AT MARKET RATES. THESE TRANSACTIONS WILL NOT BE ANNOUNCED AT THIS TIME.

THE YEN EQUIVALENT OF THE INITIAL \$1 BILLION WILL BE ACQUIRED ON JULY 26 AND THE YEN EQUIVALENT OF THE SECOND \$1 BILLION WILL BE ACQUIRED IN FOUR WEEKLY INSTALLMENTS OF \$250 MILLIUN EACH DUKING AUGUST. THE PURCHASE OF A THIRD \$1 BILLION EQUIVALENT, IF AGREED, WILL TAKE PLACE IN SEPTEMBER. IT IS PRUPOSED THAT ONE-HALF OF THE YEN BE PURCHASED ON BEHALF OF THE TREASURY'S EXCHANGE STABILIZATION FUND (ESF) AND DNE-HALF BE PURCHASED UN BEHALF OF THE FEDERAL RESERVE SYSTEM. IN KEEPING WITH OUR STANDARD ARRANGEMENTS, THE YEN ACQUIRED WILL BE INVESTED IN A REPURCHASE FACILITY WITH THE BANK OF JAPAN. THE YEN PURCHASES WILL SERVE TO INCHEASE U.S. OFFICIAL YEN RESERVES FUR POSSIBLE FUTURE USE. THE CURRENT LEVEL OF FEDERAL RESERVE SYSTEM YEN HULDINGS IS APPROXIMATELY \$155 MILLION EQUIVALENT AND THAT OF THE ESF IS APPROXIMATELY \$700 MILLION EQUIVALENT.

I RECOMMEND THAT THE COMMITTEE APPRUVE THESE ARRANGEMENTS WITH THE UNDERSTANDING THAT THE TRANSACTIONS NOT BE COUNTED AGAINST THE AUTHORIZED LIMITS IN THE PROCEDURAL INSTRUCTIONS.

CHAIRMAN GREENSPAN CONCURS IN THIS RECOMMENDATION.

IN VIEW OF THE FACT THAT THE INITIAL TRANSACTION IS TO TAKE PLACE ON TUESDAY, JULY 26, PLEASE ADVISE NORMAN BERNARD BY THE CLUSE OF BUSINESS ON TODAY WHETHER YOU CONCUR.
