## Notes on the Data (billions of dollars)

Foreign-related institutions divested \$6.4 billion in assets to nonbanks in the week ending May 5, 2010. The major asset items affected were: other securities, non-MBS, -\$0.6; commercial and industrial loans, -\$2.4; real estate loans, commercial real estate loans, -\$0.6; other loans and leases, -\$2.8; and other assets, \$6.4.

Large domestically chartered commercial banks are defined as the top 25 domestically chartered commercial banks, ranked by domestic assets as of the previous commercial bank Call Report to which the H.8 release data have been benchmarked.
