Notes on the Data (billions of dollars)

Due to the conversion of a thrift to a commercial bank during the week ending December 11, 2019, the assets and liabilities of domestic commercial banks increased \$26.7 billion. The major asset items affected were: Treasury and agency securities, mortgage-backed securities (MBS), \$3.6; commercial and industrial loans, \$0.9; real estate loans, residential real estate loans, closed-end residential loans, \$5.6; real estate loans, commercial real estate loans, secured by multifamily properties, \$8.0; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$6.0; other assets including trading assets, \$1.2; and other asset items, \$1.4. The major liability items affected were: deposits, large time deposits, \$1.9; deposits, other deposits, \$16.1; borrowings, \$6.0; and other liability items, \$0.1. The residual (assets less liabilities) increased \$2.6.
