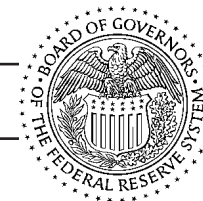

### Notes on the Data (billions of dollars)

Because of a [clarification of reporting instructions](#) for the June 30, 2022, Reports of Income and Condition (FFIEC 031, FFIEC 041, and FFIEC 051), assets of some domestically chartered commercial banks were revised during the second half of 2022. Structured financial products that are guaranteed by U.S. government agencies, such as FHLMC K-Deals and Q-Deals, are to be treated as other securities, non-MBS, rather than Treasury and agency mortgaged-backed securities (MBS). As of the week ending January 4, 2023, Treasury and agency securities, mortgage-backed securities (MBS) are estimated to have decreased \$36 billion, and other securities, non-MBS are estimated to have increased \$36 billion.

These effects on the assets of domestically chartered commercial banks due to the definitional clarifications were estimated from data reported weekly by FR 2644 sample banks. For more information on the construction of the H.8 data, please see the [About page](#).

## Footnotes

1. Data include the following types of institutions in the fifty states and the District of Columbia: domestically chartered commercial banks; U.S. branches and agencies of foreign banks; and Edge Act and agreement corporations. The latter two categories together are referred to on this release as “foreign-related institutions.” Data exclude International Banking Facilities. Weekly levels are Wednesday values; monthly levels are pro rata averages of Wednesday values. The data for domestically chartered commercial banks and U.S. branches and agencies of foreign banks are estimated by benchmarking weekly data provided by a sample of banks to quarter-end reports of condition (Call Reports). Large domestically chartered commercial banks are defined as the top 25 domestically chartered commercial banks, ranked by domestic assets as of the previous commercial bank Call Report to which the H.8 release data have been benchmarked. Small domestically chartered commercial banks are defined as all domestically chartered commercial banks not included in the top 25. The data for large and small domestically chartered banks are adjusted to remove the estimated effects of mergers and panel shifts between these two bank groups. 2.
