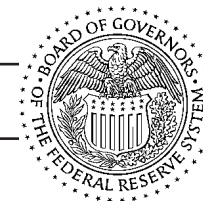
## H.8 ASSETS AND LIABILITIES OF COMMERCIAL BANKS IN THE UNITED STATES

### Notes on the Data

Because of the conversion of a thrift institution to a commercial bank in the week ending December 21, 2022, the assets and liabilities of domestically chartered commercial banks increased \$5.3 billion. The major asset items affected were the following: real estate loans, residential real estate loans, closed-end residential loans, \$3.3 billion; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$0.6 billion; and other asset item(s), \$1.4 billion. The major liability items affected were the following: deposits, other deposits, \$3.8 billion; borrowings, \$0.6 billion; and other liability item(s), \$0.4 billion. The residual (assets less liabilities) increased \$0.5 billion.

## Footnotes

1. Data include the following types of institutions in the fifty states and the District of Columbia: domestically chartered commercial banks; U.S. branches and agencies of foreign banks; and Edge Act and agreement corporations. The latter two categories together are referred to on this release as “foreign-related institutions.” Data exclude International Banking Facilities. Weekly levels are Wednesday values; monthly levels are pro rata averages of Wednesday values. The data for domestically chartered commercial banks and U.S. branches and agencies of foreign banks are estimated by benchmarking weekly data provided by a sample of banks to quarter-end reports of condition (Call Reports). Large domestically chartered commercial banks are defined as the top 25 domestically chartered commercial banks, ranked by domestic assets as of the previous commercial bank Call Report to which the H.8 release data have been benchmarked. Small domestically chartered commercial banks are defined as all domestically chartered commercial banks not included in the top 25. The data for large and small domestically chartered banks are adjusted to remove the estimated effects of mergers and panel shifts between these two bank groups. 2.
