Large domestic banks constitute a universe; data for small domestic banks and foreign-related institutions are estimates based on weekly samples and on quarter-end condition reports. Data are adjusted for breaks caused by reclassifications of assets and liabilities.

The data for large and small domestic banks presented on pages 5 to 10 are adjusted to remove the estimated effects of mergers between these two groups. The adjustment for mergers changes past levels to make them comparable with current levels. Estimated quantities of balance sheet items acquired in mergers are removed from past data for the bank group that contained the acquired bank and put into past data for the group containing the acquiring bank. Balance sheet data for acquired banks are obtained from call reports, and a ratio procedure is used to adjust past levels.

Notes on the Data

The amount of assets, originally reported on the release dated March 30, 2007, that shifted between domestically chartered commercial banks and nonbanks during the week ending March 21, 2007, has been revised to a gain of \$4.3 billion. The balance sheet items affected were (in billions): real estate loans, other residential, \$1.7 and nontransaction deposits, other, \$1.2. In addition, domestically chartered banks lost assets and liabilities to nonbanks during the week ending March 7, 2007. The balance sheet items affected were (in billions): real estate loans, other residential and nontransaction deposits, other, each \$10.0.
