Notes on the Data (billions of dollars)

Domestically chartered commercial banks acquired \$11.2 billion in assets and liabilities of nonbank institutions in the week ending April 6, 2011. The major asset items affected were: consumer loans, other consumer loans, \$6.9; cash assets, \$1.4; and other assets, \$2.6. The major liability item affected was: borrowings, borrowings from others, \$3.4. The residual (assets less liabilities) increased \$7.5.
