Notes on the Data (billions of dollars)

Because of the conversion of a thrift to a commercial bank and, additionally, the acquisition of assets and liabilities of nonbank institutions during the week ending April 1, 2020, assets and liabilities of commercial banks increased \$8.6 billion. The major asset items affected were the following: other securities, non-MBS, \$0.8 billion; commercial and industrial loans, \$3.8 billion; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$0.7 billion; other assets including trading assets, \$1.3 billion; and other asset items, \$2.1 billion. The major liability items were the following: deposits, other deposits, \$4.7 billion; borrowings, \$1.9 billion; and other liability items, \$0.3 billion. The residual (assets less liabilities) increased \$1.7 billion.
