Notice to Users of the H.8 Release

Data on this H.8 release have been benchmarked through the December 2022 Call Report. Data on the previous release were benchmarked through the September 2022 Call Report. The data also incorporate new seasonal adjustment factors. The Technical Q&As page has been updated with an entry that describes how the H.8 release handles structure activities involving large banks.

Notes on the Data

Because of the conversion of a thrift institution to a commercial bank in the week ending March 1, 2023, the assets and liabilities of domestically chartered commercial banks increased \$5.4 billion. The major asset items affected were the following: real estate loans, residential real estate loans, closed-end residential loans, \$1.5 billion; real estate loans, commercial real estate loans, secured by multifamily properties, \$0.5 billion; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$1.8 billion; and other asset item(s), \$1.6 billion. The major liability items affected were the following: deposits, other deposits, \$4.0 billion; and other liability item(s), \$0.8 billion. The residual (assets less liabilities) increased \$0.6 billion.

Because of the conversion of a thrift institution to a commercial bank in the week ending March 2, 2022, the assets and liabilities of domestically chartered commercial banks increased \$6.0 billion. The major asset items affected were the following: Treasury and agency securities, mortgage-backed securities (MBS), \$0.7 billion; Treasury and agency securities, non-MBS, \$1.0 billion; other securities, non-MBS, \$0.8 billion; real estate loans, residential real estate loans, closed-end residential loans, \$1.2 billion; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$0.9 billion; and other asset item(s), \$1.4 billion. The major liability items affected were the following: deposits, large time deposits, \$0.6 billion; other deposits, \$4.7 billion; and other liability item(s), \$0.1 billion. The residual (assets less liabilities) increased \$0.6 billion.

Because of the conversion of a thrift institution to a commercial bank in the week ending November 3, 2021, the assets and liabilities of domestically chartered commercial banks increased \$5.4 billion. The major asset items affected were the following: commercial and industrial loans, \$0.6 billion; real estate loans, residential real estate loans, closed-end residential loans, \$1.2 billion; real estate loans, commercial real estate loans, secured by nonfarm nonresidential properties, \$1.7 billion; and other asset item(s), \$1.9 billion. The major liability items affected were the following: deposits, large time deposits, \$0.5 billion; deposits, other deposits, \$4.0 billion; and other liability item(s), \$0.3 billion. The residual (assets less liabilities) increased \$0.6 billion.

- 1. Data include the following types of institutions in the fifty states and the District of Columbia: domestically chartered commercial banks; U.S. branches and agencies of foreign banks; and Edge Act and agreement corporations. The latter two categories together are referred to on this release as "foreign-related institutions." Data exclude International Banking Facilities. Weekly levels are Wednesday values; monthly levels are pro rata averages of Wednesday values. The data for domestically chartered commercial banks and U.S. branches and agencies of foreign banks are estimated by benchmarking weekly data provided by a sample of banks to quarter-end reports of condition (Call Reports). Large domestically chartered commercial banks are defined as the top 25 domestically chartered commercial banks, ranked by domestic assets as of the previous commercial bank Call Report to which the H.8 release data have been benchmarked. Small domestically chartered commercial banks are defined as all domestically chartered commercial banks not included in the top 25. The data for large and small domestically chartered banks are adjusted to remove the estimated effects of mergers and panel shifts between these two bank groups. (See www.federalreserve.gov/releases/h8/about.htm for more information on how these data were constructed.)
- 2. Includes all securities, whether held-to-maturity reported at amortized cost; available-for-sale reported at fair value; held as trading assets, also reported at fair value; or equity securities with readily determinable fair values not held for trading. Excludes all non-security trading assets, such as derivatives with a positive fair value (included in line 32) or loans held in trading accounts (included in line 9).
- 3. Treasury securities are liabilities of the U.S. government. Agency securities are liabilities of U.S. government agencies and U.S. government-sponsored enterprises.
- 4. Includes mortgage-backed securities (MBS) issued by U.S. government agencies or by U.S. government-sponsored enterprises such as the Government National Mortgage Association (GNMA), the Federal National Mortgage Association (FNMA), or the Federal Home Loan Mortgage Corporation (FHLMC). Includes pass-through securities, collateralized mortgage obligations (CMOs), real estate mortgage investment conduits (REMICs), CMO and REMIC residuals, and stripped MBS.

- 26. This balancing item is not intended as a measure of equity capital for use in capital adequacy analysis. On a seasonally adjusted basis this item reflects any differences in the seasonal patterns estimated for total assets and total liabilities.
